First time visitors are welcome with management approval. As a first-time visitor you can join as a member while here or get the information on our website and join when you come again. Management reserves right to open to open to the public and will from time to time as events warrant.**
- 6. Guests must remain in the company of the Member who invited them. If the member leaves, the guest must also leave.**
- 7. Guests who are not a spouse or significant other listed on the membership are limited to four (4) visits without joining, unless prior approval is granted by Management. All questions or requests for exceptions must be directed to Management, not our staff.**
- 6. No inappropriate clothing; Management reserves the right to ask you to leave if we feel it's offensive.**
- 7. Keep noise to limits where you can sit and talk without shouting. “Speak Easy” Keep your phone volumes down please.**
- 8. Management is in control of music, do not attempt to highjack it.**
- 9. Employees only behind bar.**
- 10. No outside beverages of any kind.**
- 11. No Drug use of any kind - No Smoking or Vaping inside. You will be asked to leave if you do. Smoking is allowed outside at top of back steps or in city parking lot only.**
